The undersigned incorporator, SCOTT A. REMINGTON, a natural person competent to contract, hereby presents these Articles of Incorporation for the formation of a corporation under the provisions of Chapter 607, Florida Statutes.

ARTICLE I - NAME

The name of this corporation is TWO CHEFS ONE FRESH IDEA, INC.

ARTICLE II - PRINCIPAL OFFICE

The address of the principal office of the corporation is 5045 North 9th Avenue, Pensacola, Florida 32504.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business under the laws of the State of Florida and the laws of the United States.

stockholders of the corporation, then such bylaw may only be amended or repealed by such supermajority vote of the stockholders.

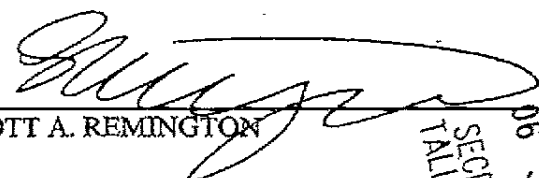
