THE NAME OF THIS CORPORATION IS PCOM OF CITRUS COUNTY  
INC

ARTICLE II EXISTANCE

THE CORPORATION SHALL HAVE PERPETUAL EXISTANCE COMMENCING  
ON  
THE DATE OF THIS FILING OF THESE ARTICLES WITH THE DEPARTMENT OF  
STATE.

ARTICLE III PURPOSE
