

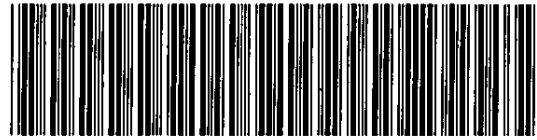

ARTICLES OF INCORPORATION
OF

A & S of Bay County Inc.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is A & S of Bay County Inc.

ARTICLE II

The existence of the Corporation shall begin on July 15, 2006.

ARTICLE III

The street address of the principal office of the Corporation is 107 Windridge Lane, Panama City Beach, Florida 32413.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 100 par value \$.01 per share, all of which shall be Common Shares. 




