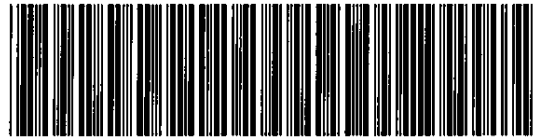


ARTICLE VIII – INDEMNIFICATION
