ARTICLES OF INCORPORATION
OF

ENDEAVOR ACCOMPLISHMENTS, INC

We, the undersigned, hereby execute these Articles of Incorporation for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida providing for the formation, rights, privileges, immunities and liabilities of corporation for profit.

ARTICLE ONE

The name of the corporation is:

ENDEAVOR ACCOMPLISHMENTS, INC

ARTICLE TWO

The general nature of the business to be conducted shall be:

The corporation may engage in any activity or business permitted under the laws of the States of America and the State of Florida, and additionally;

(A) Mortgage broker.

(B) To build, manage, promote, hold, develop, and in all other manner and form, buy and sell, let, assign or deal with real estate, whether the same by improved or unimproved, and thereon private single dwellings or multi-family structures and/or structures for dwellings, multi-family structures or commercial structures; and, in addition thereto manage, promote, hold, develop, buy or sell personal or other forms of property, both and/or mixed, wherever situate.

(C) To acquire by purchase, lease or otherwise, land and interest in lands, whether unimproved, and to own, hold, improve, develop and manage any real estate or erect or cause to be erected on any lands owned, held or accepted by the corporation, other structures, public or private, with their appurtenances, and to manage, rebuild, enlarge, alter or improve any buildings or other structures now or hereafter lands so owned, held or occupied, and to encumber or dispose of any lands or any buildings or other structures at any time owned or held by the corporation by mortgage, exchange, lease, hold for investment, or otherwise use and operate improved or unimproved, and any right or interest therein.

(D) To acquire by purchase, lease, manufacture or otherwise any personal property

useful in the equipment, furnishing, improvement, development or management of any property, real or personal, at any time owned, held, or occupied by the corporation, and to invest, trade and deal in any personal property deemed beneficial to the corporation, and to lease, rent, encumber or dispose of any personal property at any time owned or held by the corporation.

- (E) To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes and other evidences of indebtedness, and to execute such mortgages, transfers of corporation property or other instruments to secure the payment of corporate indebtedness as required.
- (F) To guarantee, endorse, purchase, hold, sell, transfer, mortgage, pledge or otherwise acquire or dispose of the shares of the capital stock of, any bonds, securities, or other evidences of indebtedness created by any other corporation of the State of Florida or any other state or government, and, while owner of such stock, to exercise all the rights, powers and privileges of ownership, including the right to vote such stock.
- (G) To purchase the corporate assets of any other corporation and engage in the same or other character of business.
- (H) To enter into, make, perform and carry out contracts and agreements of every kind, for any lawful purpose, without limit as to amount, with any person, firm, association or corporation, and to transact any further and other business necessarily connected with the purposes of this corporation, or calculate to facilitate the same.
- (I) To carry on any or all of its operations and businesses and to promote its objects within the State of Florida or elsewhere, without restriction as to place or amount; and to have, use, exercise and enjoy all of the general powers of like corporations.
- (J) To do any or all of the things herein set forth to the same extent as natural persons might do or could do, and in any part of the world, as principals, agents, contractors, or otherwise, alone or in company with others, and to do and perform all such other things and acts as may be necessary, profitable or expedient in carrying on any of the business or acts above named.
- (K) The intention is that none of the objects and powers as hereinabove set forth, except where otherwise specified in the Article, shall be in anyway limited or restricted by reference to or inference from the terms of any other objects, power or clauses of this Article or any other Articles; but that the objects and powers specified in each of the clauses in this Article shall be regarded as independent objects and powers.

ARTICLE THREE

The maximum number of shares of stock that this corporation is authorized to have outstanding at any time is Five Hundred Shares of common stock of \$1.00 par value.

ARTICLE FOUR

This corporation shall begin business with a capital of not less than Five Hundred Dollars.

ARTICLE FIVE

This corporation shall have perpetual existence.

ARTICLE SIX

The initial street address of the principal office of this corporation shall be:

The Board of Directors may, from time to time, designate such other post office address and place of the principal office of this corporation as it may see fit.

ARTICLE SEVEN

Every amendment shall be approved by the Board of Directors, proposed by them to the stockholders, and approved at a stockholders' meeting by (at least) a majority of the stockholders entitled to vote thereon, unless all of the stockholders sign a written statement manifesting their intention that a certain amendment to these Articles of Incorporation be made.
