Dear Sirs & Madams:

According to a Notice of Dissolution or Revocation I have recently received from your office, my corporation Sky Mercede, P.A. has been dissolved effective September 14, 2007. I filed my 2007 annual report in a timely fashion by April 30, 2007, saw that the check for \$150 cleared in my bank statements (which made me think everything was taken care of). I have no recollection of receiving the first notice of rejection of my annual report. When I received your second notice of rejection (my first notice of rejection), I resubmitted my annual report with a copy of the check and attached a copy of my Application for Employer Identification Number with my EIN # in the upper right hand corner. Mistakenly, I didn't write the EIN # on my annual report that was sent in with the notice of rejection. With my social security number on the application the Division of Corporations did not want to post or file that with my annual report on the website. Due to this confusion on both sides I am respectfully requesting abatement from the \$600 reinstatement fee for reinstating my corporation. As you can see from the above mentioned time line of events that took place I was making attempts to correct the situation.
