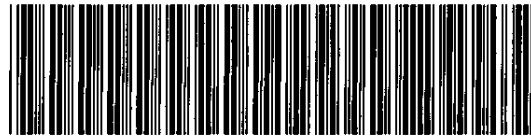

## ARTICLE VI






