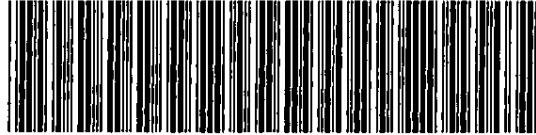

ARTICLE X, AMENDMENT






