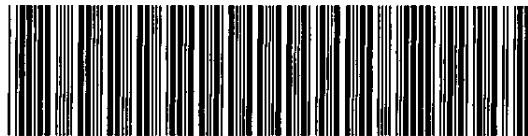



The undersigned, for the purposes of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

**I**

The name of the corporation shall be *GREATER FLORIDA HOME INSPECTIONS OF CENTRAL FLORIDA, INC.*. The principal place of business shall be 449 Amethyst Way, Lake Mary, Florida 32744.

**II**

The duration of this corporation is perpetual unless dissolved according to law.

**III**

The purposes for which this corporation is organized are:

1. To provide inspections of properties prior to and in conjunction with real estate transactions, for members of the general public and businesses.
2. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporations Act.
