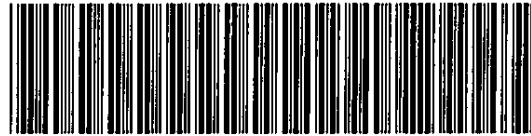

ARTICLES OF INCORPORATION OF MICHELE BOYD TITLE SERVICES, INC.

The undersigned subscriber to these Articles of Incorporation ("Articles"), being a natural person and competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE I. - NAME. Michele Boyd Title Services, Inc. is the name of this Corporation (hereinafter referred to as the "Company").

ARTICLE II. - PRINCIPAL OFFICE. The principal office of the Company is 6339 Land O' Lakes Boulevard, Land O' Lakes, Florida 34638.

ARTICLE III. - DURATION. The Company's existence commenced upon the filing of these Articles with the Florida Department of State, and the Company will exist perpetually, unless terminated in accordance with law.

ARTICLE IV. - PURPOSE. The purpose for which the Company is being formed is to engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE V. - CAPITAL. This Corporation is authorized to issue seven thousand five hundred (7,500) shares of one dollar per share par value common stock.

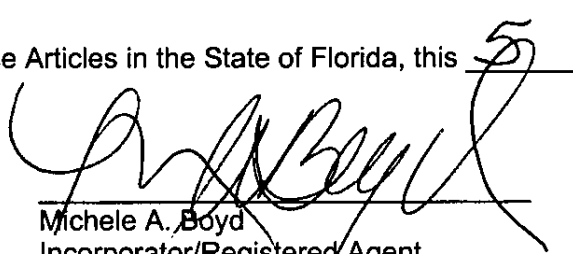
