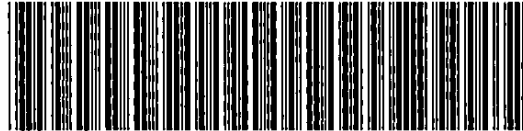

ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
SCULLIN & SOBELMAN, P.A.

The Articles of Incorporation of the undersigned corporation were originally filed on July 12, 1996 and assigned document number P06000092077. The Articles of Incorporation were amended and restated on August 30, 2006. Pursuant to Sections 607.1003 and 607.1006 of the Florida Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation (these "Articles of Amendment"):

1. The name of the corporation is Scullin & Sobelman, P.A. (the "Corporation").
2. "Article 1. Name" of the Articles of Incorporation of the Corporation is amended to read as follows:

"Article 1. Name

The name of the Corporation is:

Scullin & Sobelman, Inc."

3. The Articles of Amendment were duly approved and unanimously adopted by the Directors of the Corporation on September 12, 2006. The Directors recommended approval of the Articles of Amendment to the Shareholders.
4. The Articles of Amendment were voted upon and duly approved, adopted, and ratified by the Shareholders of the Corporation on September 12, 2006.
5. The number of votes cast for approval of the Articles of Amendment by the Shareholders was sufficient for approval.
6. In all other respects, the Articles of Incorporation shall remain as they were prior to these Articles of Amendment being adopted.
