RE-STATED ARTICLES OF INCORPORATION OF BE-SURE, INC.

BE-SURE, INC.

The undersigned do hereby subscribe to, acknowledge and file the following Re-Stated Articles of Incorporation for the purpose of creating a corporation under the laws of the

ARTICLE 1 - NAME AND ADDRESS

The name of this corporation is Be-Sure, Inc. and the address is 6073 N.W. 167th Street, #C-6, Miami Lakes, FL 33015

ARTICLE II- PURPOSE

This corporation is organized for the purpose of:

State of Florida.

- 1. Transacting any and all lawful business for which a corporation may be incorporated under Florida Statues.

ARTICLE III - CAPITAL STOCK
