ARTICLES OF INCORPORATION OF UNIQUE REFINISHING, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation is Unique Refinishing, Inc. (the "Corporation"
