ARTICLES OF INCORPORATION OF PENNY LANE TOO, INC.

THE UNDERSIGNED, acting as sole incorporator of PENNY LANE TOO, INC. under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I NAME
