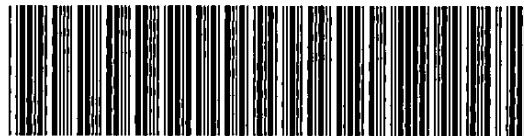

#### **Indemnification**

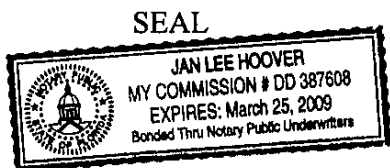

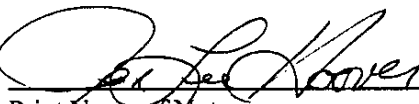
