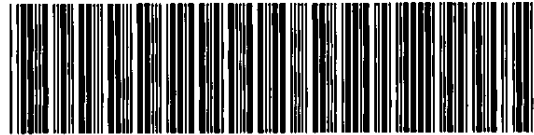

NAME




