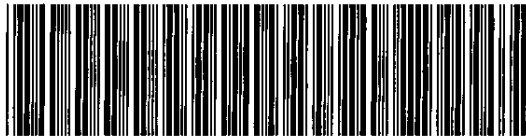


ARTICLE XIII
