

## CERTIFICATE OF INCORPORATION OF YMY ENTERPRISES INC.

We, the undersigned, in order to from a corporation for the purpose hereinafter stated, under and pursuant to the provisions of the Several Acts of Legislature of the State of Florida, do hereby subscribe to this certificate of incorporation.

**FIRST:** The name of the corporation is:

and its principal place of business will be at:

<u>SECOND</u>: The business of this corporation shall be to engage in any and all lawful business or businesses.

**THIRD:** The corporation shall have one class of stock, namely common, voting and participating. Each share of stock shall be \$1.00 par value and the maximum of shares to be issued and outstanding at any one time is 1000.

All of such stock shall be issued as fully paid for and exempted from assessment. Such stock may be paid for in property, labor or services and property and labor or services may be purchased or paid for by the corporation with such stock. Likewise stock of other corporations of going businesses may be purchased by corporation in return for this corporation's stock.
