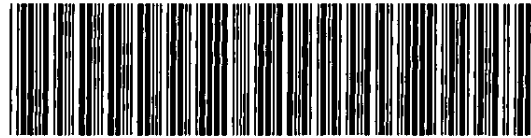

**ARTICLE I

These articles of incorporation may be amended in the manner provided by law.

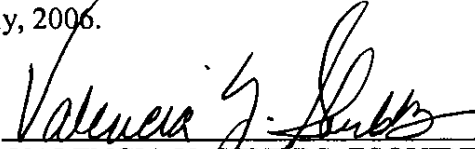
