

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I - NAME

The name of the Corporation shall be WOLF'S CUSTOM CATERING, INC.

ARTICLE II - BEGIN EXISTENCE

The existence of the Corporation shall begin on July 15, 2006.

ARTICLE III - PURPOSE

The Corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV - REGISTERED OFFICE

The street address of the principal office of the Corporation is 308 65th Street Court, NW, Bradenton, FL 34209.

ARTICLE V - AUTHORIZED SHARES

The maximum number of shares this Corporation is authorized to issue is one hundred (100), par value \$5.00 per share, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

ARTICLE VI - REGISTERED AGENT

The initial street address of the Corporation's registered office is 308 65th Street Court, NW, Bradenton, FL 34209. The initial registered agent for the Corporation is MARK WOLF.

ARTICLE VII - INITIAL BOARD OF DIRECTORS

The Corporation shall indemnify its directors, officers, employees and agents to the fullest extent permitted by law.


ARTICLE X - BYLAWS


