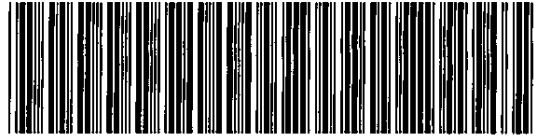

## **ARTICLE I – NAME**
