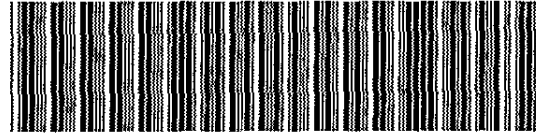


These articles of correction correct the Articles of Incorporation, filed with the Department of State on July 19, 2006.
