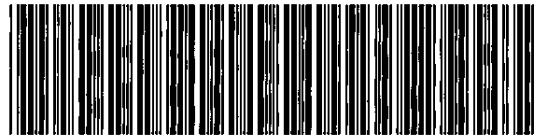

The undersigned hereby form a corporation-for-profit under the Florida General Corporation Act by adopting the following Articles of Incorporation:

1. Name. The name of this corporation is Public Employees Services Company.
2. Nature, Purpose and Powers. The corporation shall have perpetual existence, commencing on the date that these Articles are executed and acknowledged with the power to engage in any lawful business and have all powers enumerated in the Florida General Corporation Act.
3. Capital Stock. The corporation is authorized to issue 1,000 shares of \$1.00 par value common stock.
4. Initial Registered Agent and Office. The name and address of the initial Registered Agent of this corporation is James W. Geiger, 1220 East Park Avenue, Tallahassee FL 32301.
5. Initial Board of Directors. This corporation shall have one director initially. The number of directors may be either increased from time to time as may be provided in the Corporation's Bylaws but shall never be less than one. 7. Indemnification. The corporation will indemnify any officer or director, or any former officer or director, pursuant to Section 607.014 of the Florida Statutes, as amended.
