

COMES FORWARD, the undersigned subscribers to these Articles, being natural person competent to contract under the Laws of the State of Florida, do hereby establish themselves and hereby organize and incorporate a private for-profit corporation in compliance with Chapters 607, Florida Statues.

ARTICLE I Name
