ARTICLES OF INCORPORATION OF PISCISECURE USA, INC.

ARTICLE I NAME

The name of this Corporation is PISCISECURE USA, INC. and its mailing address is 5951 SW 88th Street, Miami, Florida 33156.

ARTICLE II NATURE OF BUSINESS

Dividends payable in shares of any class may be paid to the holders of shares of any other class.

ARTICLE XIII INDEMNIFICATION

This corporation shall indemnify any and all of its directors, officers, employees or agents or former directors, officers, employees or agents or any person or persons who may have served at its request as a director, officer, employee or agent of another corporation, partnership, joint venture, trust or other enterprise in which it owns shares of capital stock or of which it is a creditor, to the fullest extent permitted by law. party, by reason of his being or having been a director, officer, employee or agent as herein provided. The foregoing right of indemnification shall not be exclusive of any other rights to which any director, officer, employee or agent may be entitled as a matter of law or which he may be lawfully granted.


