ARTICLES OF INCORPORATION
OF

The undersigned subscribes to these Articles of Incorporation for the purpose of forming a corporation pursuant to the provisions of the Florida Business Corporation Act, Chapter 607, Florida Statutes.

ARTICLE I

The name of the corporation is "Teachers for Public Education Excellence, Inc." The principal place of business is: 2200 Biscayne Blvd., Miami, Florida 33137.

ARTICLE II

This corporation shall have perpetual existence.


