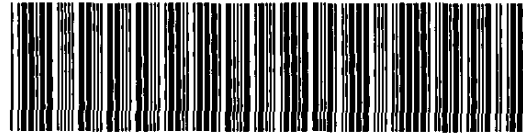


ARTICLE VI—BOARD OF DIRECTORS




