ARTICLES OF INCORPORATION

I, SHEILA CHANDRAHASA, the undersigned, who is licensed to practice in the profession of Dentistry in the State of Florida, do hereby make, subscribe, acknowledge and file with the Secretary of State of the State of Florida, these Articles of Incorporation for the purpose of forming a professional service corporation for profit in accordance with the laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation shall be: SHEILA CHANDRAHASA, D.M.D, P.A.

ARTICLE II - PURPOSE

The purposes for which this corporation is formed are:

- A. To engage in the practice of dentistry as a professional corporation and to carry on services incident thereto. The practice of dentistry is the sole and exclusive professional service to be rendered by this corporation.
- B. To own property, enter into contracts, and carry on any business necessary or incidental to the accomplishment or furtherance of the purpose or objects of this corporation.
- C. The professional services of this corporation shall be carried out only through officers, employees, and agents, each of whom has been licensed as a Dentist in the State of Florida.

ARTICLE III - CAPITAL STOCK

- A. The total number of shares of capital stock which the corporation shall be authorized to issue is One Thousand (1,000) shares. Such shares shall be of a single class of common stock and shall have a par value of \$1.00 per share.
- B. Each shareholder must be a duly licensed Dentist in the State of Florida.
- C. No shareholder shall enter into a voting trust agreement or any other type agreement vesting another person with the authority to exercise the voting power of any or all of his stock.

<u>ARTICLE IV - RESTRAINT ON ALIENATION OF SHARES</u>

The shareholders of the professional service corporation shall have the power to include in the bylaws, or by separate agreement adopted by a majority of the shareholders of the professional service corporation, any regulatory or restrictive provisions regarding the proposed sale, transfer, or other disposition of any of the outstanding stock of the professional service corporation by any of its shareholders, or in the event of the death of any of its shareholders. The manner and form, as well as the relevant terms, conditions, and details, of the disposition shall be determined by the shareholders of the professional service corporation; provided, however, that such regulatory or restrictive provisions shall not affect the rights of third parties without actual notice of the provisions unless the existence of the provisions is plainly noted on the certificate evidencing ownership of such stock. No shareholder of the professional service corporation may sell or transfer stock of the corporation except to another individual who is eligible to be a shareholder of the professional service corporation, and the sale or transfer may be made only after it has been approved at a shareholder meeting especially called for that purpose. If any shareholder becomes legally disqualified to practice as a Dentist in the State of Florida, that shareholder's shares of stock shall immediately become subject to purchase by the professional service corporation in accordance with the bylaws adopted by the shareholders.

ARTICLE V - DURATION

This corporation shall have perpetual existence commencing as of the date of execution of these Articles.

ARTICLE VI - INITIAL PRINCIPAL OFFICE AND AGENT

The street address of the initial principal office of this corporation is 1743 NW 81 Way, Plantation, FL 33322, and the name of the initial registered agent of this corporation at that address is SHEILA CHANDRAHASA.

ARTICLE VII - BOARD OF DIRECTORS

There shall be a board of directors for this corporation which shall consist of ONE (1) director initially. The number of directors may be increased from time to time in accordance with the By-Laws of the corporation.
