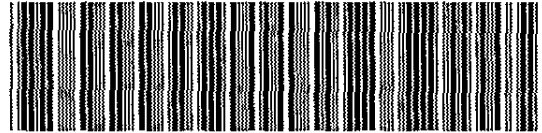

ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS

The name of this corporation is MURPHY & SONS CLEANING SERVICES, INC., and its principal place of business shall be located at 1626 Seahouse Street, Sebastian, Florida 32958.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of the filing of these Articles of Incorporation with the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of construction and household cleaning, handyman services, and for transacting any and all lawful business.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue ONE HUNDRED (100) shares of common stock at TEN DOLLARS (\$10.00) par value, which shall be designated as "Common Shares."

#### ARTICLE XI - AMENDMENT

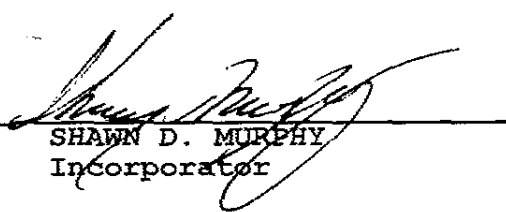
This corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation, or any

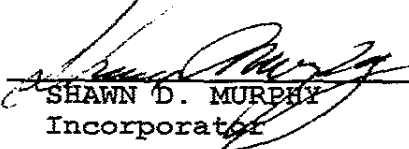

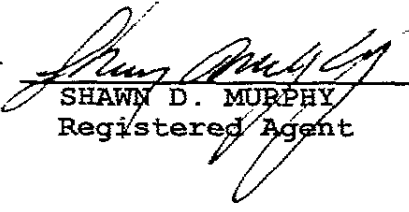
