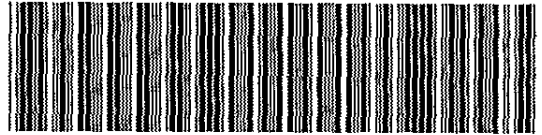



Pursuant to the provisions Chapters 607 and 621 of the Florida Statutes, this Florida profit corporation adopts the following Articles of Incorporation of Michelsen Properties, Incorporated, filed on July 17, 2006.

ARTICLE I - NAME

The name of this corporation is MICHELSEN PROPERTIES, INCORPORATED.

ARTICLE II - DURATION PRINCIPLE PLACE OF BUSINESS AND MAILING ADDRESS OF CORPORATE OFFICE
