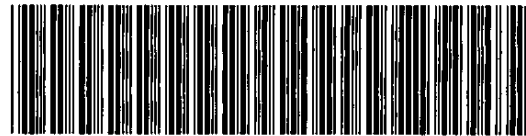

The undersigned hereby forms a Florida professional service corporation under Chapter 621 of the laws of the State of Florida.

ARTICLE I. NAME AND ADDRESS


