ARTICLES OF INCORPORATION
OF

BLACKSTONE AVIATION GROUP, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation is **BLACKSTONE AVIATION GROUP, INC.** and it is located at 11600 N.W. 34th Street, Miami, Florida 33178.

ARTICLE II

DURATION

The duration of the corporation is perpetual.

ARTICLE III

PURPOSE

The general purposes for which the corporation is organized are:
