# ARTICLES OF INCORPORATION OF HAVEN TRUST BANK

pancial institution

The undersigned, acting as directors for the purpose of forming a financial institution corporation in accordance with the Laws of the State of Florida, adopts the following Articles of Incorporation.

#### ARTICLE I

The name of the bank shall be Haven Trust Bank and its initial place of business shall be at 709 South Ponce de Leon Boulevard, in the City of St. Augustine, in the County of St. Johns and State of Florida. These Articles shall be effective upon filing.

#### ARTICLE II

The general nature of the business to be transacted by this bank shall be that of a general commercial banking business with all the rights, powers, and privileges granted and conferred by the Florida Financial Institutions Code, regulating the organization, powers, and management of banking corporations.

#### **ARTICLE III**

The total number of shares authorized to be issued by the bank shall be twenty million (20,000,000). Such shares shall be of a single class and shall have a par value of \$5.00 per share. The bank shall begin business with at least \$7,000,000 in paid-in common capital stock to be divided into 1,400,000 shares. The amount of surplus with which the bank will begin business will be not less than \$6,253,000 all of which shall be paid in cash.

#### ARTICLE IV

The term for which said bank shall exist shall be perpetual unless terminated pursuant to the Florida Financial Institutions Codes.

#### ARTICLE V

The number of directors shall not be fewer than five (5). A majority of the full board of directors may, at any time during the years following the annual meeting of shareholders, increase the number of directors by not more than two and appoint persons to fill resulting vacancies.
