

## ARTICLES OF INCORPORATION

The undersigned incorporator and subscriber to these articles of incorporation adopts these articles to form a corporation in compliance with Chapter 607 and/or Chapter 621, F.S. (Profit), and other laws of the State of Florida.

### Article I      Name

The name of the corporation is: Southern Fence Installers, Inc.

### Article II      Address

The street address of the initial principal office and mailing address of the corporation is:

### Article III      Purpose

The corporation is formed to engage in every phase and aspect of residential and commercial fence manufacturing, installation & servicing and any other area to provide a full range of maintenance and improvement services. In addition, the corporation may invest the funds of the corporation in real estate mortgages, stocks, bonds, or any other type of investment, and own real and personal property necessary for the rendering of residential & commercial maintenance and improvement service to customers.

### Article IV      Terms of Existence

The corporation is to exist perpetually.

### Article V      Capital Stock

The corporation shall have the authority to issue 10,000 shares of common capital stock with a par value of \$0.01 per share.

#### **Article VI Initial Officers and/or Directors**

The manner and form, as well as the relevant terms, conditions, and details of the disposition, shall be determined by the stockholders of the corporation; provided, however, that such regulatory or restrictive provisions shall not affect the rights of third parties without actual notice of the provisions unless the existence of the provisions are plainly noted on the certificate evidencing the ownership of such stock. No stockholder of the corporation may sell or transfer stock in the corporation unless the sale or transfer has been approved at a stockholder meeting especially called for that purpose.

#### **Article X Indemnification**

The corporation shall indemnify its directors, officers, employees, and agents to the full extent permitted by law.


**Article XI** **Amendment**

The existence of the corporation shall commence at 12:01 a.m. on July 24, 2006.


