ARTICLE ONE

The name of this corporation is: INGENIOUS CREATIONS CORP.

The principal office and mailing address of this corporation is: 1200 N.W. 78 AVENUE, STE 216, MIAMI, FL. 33126

ARTICLE TWO

NATURE OF BUSINESS

This corporation may engage in any activity or business related that are permitted under the laws of the United States of America and the laws of the State of Florida.

ARTICLE THREE

DURATION

This corporation shall have perpetual existence unless sconer dissolved in accordance with the laws of the State of Florida. The date on which corporate existence shall begin is: UPON APPROVAL BY SECRETARY - OF STATE.
