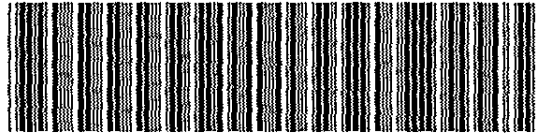



**Article I: NAME**

The name of the corporation shall be QUALITY DISCOUNT IMPORTS, Corp.

**Article II: PRINCIPAL OFFICE**

The principal place of business for the operating office and mailing address of this corporation shall be 11440 SW 186 Street, Miami, Florida 33157.

**Article III: PURPOSE**

The specific purpose of this corporation shall be wholesale supply.

**Article IV: SHARES**

The number of shares of stock that QUALITY DISCOUNT IMPORTS, Corp. is authorized to have is 1,000 with par value of \$1.00 per stock on the effective date of the articles.

**Article VI: REGISTERED AGENT**

**Article VII: INCORPORATOR**

**Article VIII: EFFECTIVE DATE**

2. The act or acts of the shareholder(s) is deemed illegal by the laws of the state of Florida.
3. The act or acts of the shareholder(s) is deemed misconduct by the majority of the other shareholder(s).

#### Article XIII: OFFICER LIABILITY

The Chief Executive Officer(s) shall not any imposition of personal liability for the corporation debts unless:

1. The act or acts of the officer(s) is inconsistent with the purpose of the corporation.
2. The act or acts of the officer(s) is deemed illegal by the laws of the state of Florida.
3. The act or acts of the officer(s) is deemed misconduct by the majority of the other shareholder(s).
4. The act or acts of the officer(s) is beyond the scope of Article X and related By-Laws.

#### Article XIV: DIRECTOR LIABILITY

The Director(s) shall not any imposition of personal liability for the corporation debts unless:

1. The act or acts of the director(s) is inconsistent with the purpose of the corporation.
2. The act or acts of the director(s) is deemed illegal by the laws of the state of Florida.
3. The act or acts of the director(s) is deemed misconduct by the majority of the other shareholder(s).
4. The act or acts of the director(s) is beyond the scope of Article XI and related By-Laws.

Article XV: TYPE OF CORPORATION

QUALITY DISCOUNT IMPORTS, Corp. shall be registered as an S corporation for IRS taxing purposes.


Article XVI: BY-LAWS
