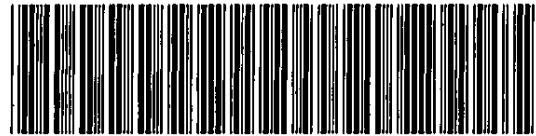

The name of this corporation is BACKWATER BAY REAL ESTATE, INC. and the mailing address of the corporation shall be 14862 Crescent Cove Dr., Fort Myers, Florida 33908.

ARTICLE TWO

The date of the commencement of corporate existence of the corporation shall be the date these Articles are executed.
