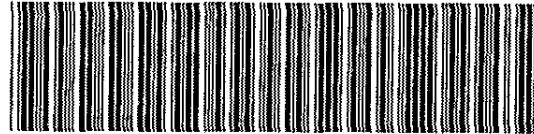



1. Article 9 of the Articles of Incorporation of Prestige Limousine of Greater Florida, Inc., is hereby amended to read as follows:


The names and addresses of the subscribers to these Articles of Incorporation, and the number of shares of each agrees to take are as follows:

2. The foregoing amendment was adopted by the shareholders of this corporation on the 22nd day of December 2006.


