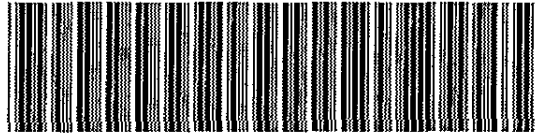

ARTICLES OF INCORPORATION

of

C.M.Q. Unlimited the undersigned incorporators, for the purpose of forming a corporation under the Florida Corporation Sct, hereby the following Articles of Incorporation.

ARTICLE I - NAME
