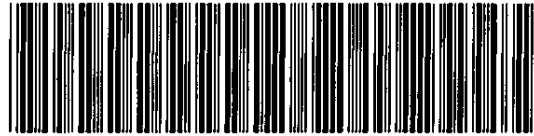

**ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS**

The name of this corporation is ADVANCED CABINET WORKS, INC. and its principal place of business shall be located at 12833 Anderson Hill Road, Clermont, Florida 34711.

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

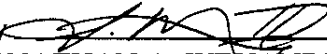
