The undersigned incorporator hereby forms a professional corporation under Chapter 621 of the Laws of the State of Florida.

ARTICLE I NAME

The name of the professional corporation shall be:

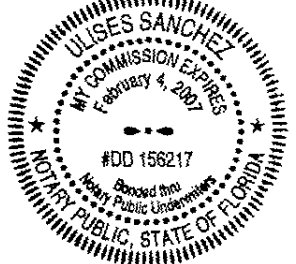
