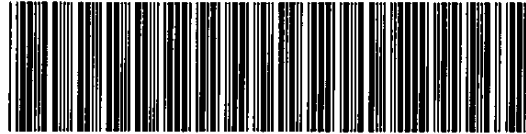

ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is **TAMI L. GRISWOLD, P.A.**

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing on the date of signing.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business, including acting as trustee, and that of a Real Estate Associate.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 7,500 shares of no par value common stock.

ARTICLE V - PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he/she already holds, shall have the right to purchase his/her pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which is offered to others.

This corporation shall have the power to act as trustee, as well as all of the corporate powers enumerated in the Florida Statute covering Professional Associations.


ARTICLE X – INDEMNIFICATION
