ARTICLES OF INCORPORATION

OF

PITCH COUNT BASEBALL ACADEMY, INC.



ARTICLE I - NAME

The name of the corporation shall be PITCH COUNT BASEBALL ACADEMY, INC. The mailing address for the corporation is 14835 US Highway 301 North, Parrish, Florida 34219.

ARTICLE II - DURATION

This corporation shall exist perpetually.

ARTICLE III - PURPOSE
