ARTICLE I - CORPORATE NAME

ARTICLE II - CAPITAL STOCK

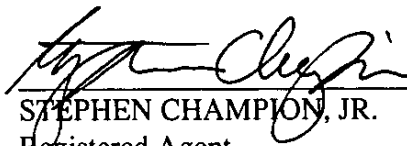
