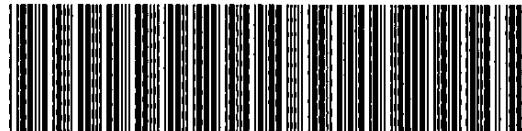

OF

ARTICLE I - NAME

The name of this corporation is EXCEPTIONAL CONSULTING FOR EDUCATIONAL LEADERS, INC. (hereinafter, "Corporation").




