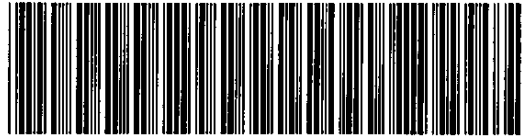

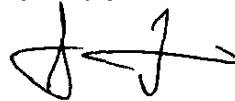

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

**ARTICLE I: NAME AND PRINCIPAL OFFICE ADDRESS**

The name of this corporation is Express Printing & Mailing, Inc., and its principal office address is 698 East Heinberg Street, Suite 104, Pensacola, Florida 32501.

**ARTICLE II: DURATION**

This corporation shall exist perpetually, commencing upon the date of filing of these Articles of Incorporation.
