ARTICLES OF INCORPORATION

The undersigned Subscriber, for the purpose of forming a professional service corporation in accordance with Chapter 621 of the Florida Statutes and the Florida Professional Service Corporation Act, does hereby adopt the following Articles of Incorporation.

Article 1 - Name and Address

The name of this Corporation is R. MAURICE BONILLA, M.D., P.A. The principal place of business of this Corporation shall be 905 W. Platt St., Tampa, Florida 33606, or such other place as may be designated by the Board of Directors.
