ARTICLE I NAME

ARTICLE, II NATURE OF BUSINESS

The nature of the business to be transacted by this Corporation is to render services in real estate in the State of Florida, pursuant to Chapter 475 of the Florida Statutes and applicable laws, through its officers, employees and agents, who are duly licensed and legally authorized to render such professional services within this state.
