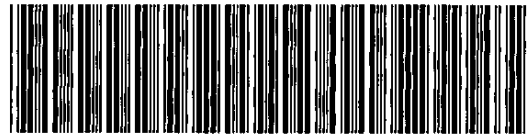

**ARTICLES OF INCORPORATION**

**FOR**

In compliance with Chapter 607 and/or Chapter 621, F.S. (Profit), I the undersigned, being of legal age and a natural person do hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

**ARTICLE I NAME**

The name of the corporation shall be JOLA Services, Inc.

**ARTICLE II PRINCIPAL OFFICE**

The principal place of business/mailling address of this corporation shall be located at 4948 NE 19 Avenue, Pompano Beach, Florida 33064.
