#### ARTICLES OF INCORPORATION OF

## H E SYSTEMS

#### ARTICLE 1 - NAME

The name of the corporation (hereinafter called the corporation) is H E SYSTEMS, INC.

#### ARTICLE 2 – PRINCIPAL OFFICE

The principal place of business/mailing address is:

#### ARTICLE 3 - PURPOSE

The purpose for which the corporation is organized are: 1) to research, develop and sell engineering software products and 2) to engage in any lawful activity for which corporations may be formed under Florida corporation laws.

#### <u>ARTICLE 4 - SHARES</u>

The total number of shares of capitol stock which the corporation has authority to issue is 50,000 divided into 25,000 shares of Class A common stock with \$0.01 par value and 25,000 shares of Class B common stock with \$0.01 par value. - 2. With respect to voting powers, except as otherwise required by the laws of the State of Florida, the holders of Class A common stock shall possess all voting for all purposes including the election of directors, and holders of Class B common stock shall have no voting power whatsoever, and no holder of Class B common stock shall vote on or otherwise participate in any proceedings in which actions shall be taken by the corporation or the stockholders thereof or be entitled to notification as to any meeting of the Board of Directors or the stockholders.

#### ARTICLE 5 - INITIAL OFFICERS AND/OR DIRECTORS

The number of directors constituting the initial Board of Directors of the corporation is one (1), this being TIMOTHY A. HITESHEW.

#### ARTICLE 6 - REGISTERED AGENT
